2. BACKGROUND

Ultra Electronics Controls has identified that the Zone Controller Fuse 1 has a marginal condition which during an in-rush current state may cause the Fuse 1 to activate (open circuit) with no other fault conditions present. This modification has been introduced as an improvement to replace Fuse 1 with a different specified fuse to prevent the premature activation of Fuse 1. The Zone Controller remains Part Number: 003-CM-00-0200 with the change identified as Modification "A" on the Front Panel.

3. DESCRIPTION

The Zone Controller Fuse 1 and Resistor 115 are replaced with different specified parts to prevent the premature activation of the Fuse 1. Information on the replacement specified parts will detailed in the next revision of CMM 30-11-40.

4. SUPPORT INFORMATION

As the Zone Controller remains Part Number: 003-CM-00-0200 the pre-modified and post-modified Zone Controller continues to be fully interchangeable and intermixable.

Ultra Electronics Controls will accomplish Modification "A" on all Zone Controllers that are returned for maintenance on an attrition basis only; when a Zone Controller is removed for a fault condition; normal conditions and warranty terms will apply.
